“Sri Ganesha Hindu Tempel e.V.” is a registered organization in Berlin that promotes awareness of Hindu religious customs and tradition for not only for Hindus but also for other people regardless of their ethical origins living in Germany.

The association requires contact information of its members to contact them via post, email and/or telephone on the following occasion:

1. To contact association’s members for the help needed for the planning and conducting cultural and religious activities successfully
2. To inform association’s members about the organized cultural and religious activities
3. To provide the association’s members the contact information of the other members’ contact information (only if willingness from association’s member is provided in written) to furnish the contact between members and their family
4. To transfer the message to particular association member if asked by any temple visitors

A Data Privacy Law required a written permission from the association’s member. The Law also provides an option to withdraw the permission at any time by informing temple committee in written.
